Sir,

In producing here with one arrested accused person namely Budhu Gorain (40) S/O Lt. Pustam Gorain of vill- Pat Jhalda, P.S- Jhalda, Dist- Purulia and brought under seizure 02 (two) plastic Jaricans containing approx 10 (Ten) Ltrs. ID liquor each jaricans , total 20 (twenty) ltrs. ID liquor from his possession. I do hereby lodged this written complain to the effect that on 05/03/2021 at about 19:15 hrs, during special evening mobile duty I received a telephonic source information that one person is selling I.D. liquor from his house at vill-Pat Jhalda, P.S- Jhalda, Dist- Purulia to the villagers in lieu of money. I informed the matter to I/C Jhalda P.S over phone and as per his direction myself along with force C/497-Ambuj Mandal, C/696-Gorapada Pal vide C.C. No-638/2021 date 05/03/2021 left to work out the said source information. We reached at Pat Jhalda at about 19:45 hrs. and held raid in the dwelling house of Budhu Gorain S/O Lt. Pustam Gorain of vill- Pat Jhalda, P.S- Jhalda, Dist- Purulia but seeing the Police party we saw some persons fled away from his house but we managed to apprehend the house owner namely Budhu Gorain. We searched his house and found 02 (two) plastic Jaricans containing approx 10 (Ten) Ltrs. ID liquor each jaricans , total 20 (twenty) ltrs. ID liquor in his house . I asked him to produce licence or any valid document in respect of keeping such amount of ID liquor and selling to the villagers. But he failed to produce any valid document in respect of said 1D liquor. During interrogation he disclosed his identity as noted above and confessed that he sell this ID liquor to the villagers in lieu of money. Accordingly I seized 02 (two) plastic Jaricans containing approx 10 (Ten) Ltrs. ID liquor each jaricans, total 20 (twenty) ltrs. ID liquor under proper seizure list duly signed by the witnesses as well as accd. person with proper label. I search for local witnesses but none is there. I arrested him maintaining all formalities of arrest.

On return to PS along with accd, person and all seizure articles. Put the accd, person in the Lockup after maintaining all formalities and seized articles kept in PS Malkhana and I pray a specific case may kindly be lodged against Budhu Gorain (40) S/O Lt. Pustam Gorain of vill- Pat Jhalda, P.S-Jhalda, Dist- Purulia and arrange for investigation.
