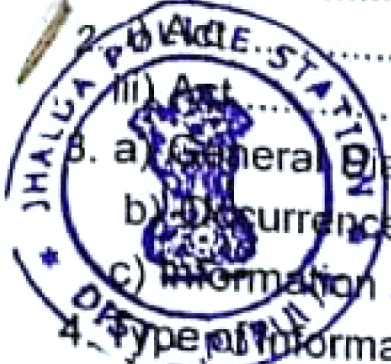

Sir,

In producing here with one arrested accused person namely Sanat Dutta (60 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 20 (Twenty) Pcs sealed bottles of OWNREX Cough Syrup @ Rs. 137/- per bottle, having 100 ml in each bottle (ii) 04 (Four) bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Malete Syrup Choco-Dx Cough Syrup @ Rs. 101/- per bottle having 100 ml in each bottle from the possession of the accused person mentioned above. I ASI- Habibul Rahaman Mandal of Jhalda PS do here by lodged a written complaint to the effect that on 05.03.2021 at 20:15 hrs, in-course of my evening mobile duty near at Baragram Bagan side, I received an information over Mobile phone from my source that one person, the owner of the Annapurna Medical Hall has stored huge quantity of Cough Syrup for selling clandestinely from his shop styled as "Annapurna Medical Hall" to the youth customers of Jhalda town area. After having received this information I immediately informed to I/C Jhalda PS and as per direction of I/C Jhalda, I ASI- Habibul Rahaman Mandal along with C/386 Sibendhu Sinha, C/571 Md. Hasib Khan, HG/1636 Harekrishna Ghosh and NVF/039 Lalit Kishore Mahato all of Jhalda PS left Baragram Bagan immediately at 20:25 Hrs to work out the information. We, all reached with Govt. Vehicle near Annapurna Medical Hall near at Bus-Stand at 20:45 Hrs. and held raid at above noted medical shop and found (i) 20 (Twenty) Pcs sealed bottles of OWNREX Cough Syrup @ Rs. 137/- per bottle, having 100 ml in each bottle (ii) 04 (Four) bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Malete Syrup Choco-Dx Cough Syrup @ Rs. 101/- per bottle having 100 ml in each bottle in his shop. On interrogation he disclosed his identity as the owner of the shop as mentioned above. He also disclosed that he was running Cough Syrup (illegal drugs) business since long from his "Annapurna Medical Hall" illegally and today he was with huge quantity of Cough syrup in his shop and keep there for the purpose of selling illegal drugs to the local youth customers. On demand he failed to produce any valid documents/ license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and on request no one come forward to be the witness in this case and as well as signed by the apprehended person and also prepared label with seal of one bottle of Cough Syrup from each item as sample taking among the seized bottles. I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 having informed him the ground of arrest and maintaining all formalities.

I, therefore pray before you to start a case against accused person named Sanat Dutta (60 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
