Sub : - Complaint against MCC violation

Sir,

I, PSI Habibur Rahman returned to PS with 02 (two) seized Motor Cycles (i) One Yamaha Bike having Reg. No- WB 56M 9115 and (ii) One Passion Pro bike having Reg. No- JH 10T 1050 and 02 (two) flags of AJSU party and lodged this complaint to the effect that on 13/03/2021 myself along with other FST team members namely Swarup Panda, Magistrate of Flying Squad Team of Jhalda Block, Ranjit Kr. Mahata and force were performing FST duty in C/W Assemble Election 2021. At 16:05 hrs myself with force reached at Kiribera village, PS-Jhalda, Dist-Purulia and found about 20/22 persons with Motorcycles organized a rally and campaigning for AJSU party. We stopped them as per direction of Magistrate of FST team and asked them to produce any valid permission order for organizing rally with Motorcycle and campaigning. But seeing us they started to flee away. Somehow we managed to apprehend 02 (two) Motorcycles with riders. On being asked they disclosed their identity as (i) Sanjay Mahato S/O Naresh Ch. Mahato of vill- Raidih, PS-Jhalda, Dist-Purulia and (ii) Srimanta Karmakar S/O Budhu Karmakar of do. On being asked they failed to any document related to their permission for rally and campaigning. Thus it is a case of MCC violation in ensuing Assembly Election 2021, as per notification by FCI. So, I seized above noted two Motorcycles and flags with proper seizure list as per direction of Magistrate of FST team and in presence of other members of FST team.

Therefore, I pray a specific case may kindly be lodged against (i) Sanjay Mahato S/O Naresh Ch. Mahato of vill- Raidih, PS-Jhalda, Dist-Purulia and (ii) Srimanta Karmakar S/O Budhu Karmakar of do and 20/22 others followers/supporters of AJSU party under proper section of Law.
