Sir,

In producing here with 01 (one) arrested accused person namely Anoj Kumar Mahto (35) S/O Naidab Mahto of vill- Kancho, P.O- Tutki Nawadhi, P.S- Silli, Dist- Ranchi (JKD) and brought under seizure i) 01 (one) plastic Jarican containing approx 20 (twenty) Ltrs. ID liquor and ii) 01 (one) steel and black colour Hero Passion pro Motor Cycle having Reg. No-JH01BT-1378, chassis no. MBLHA10BSFHF36878, engine no HA10EVFHF37703 from his possession. I do hereby lodged this written complain to the effect that on 22/03/2021 at about 18:45 hrs while I along with force, and FST team (Buddhadeb Mahato IDO of Jhalda-I BDO office FST Magistrate of WBLE-2021, Swarup Panda, ADA Jhalda-I, Ranjit Kr. Mahato of Jhalda-I Block office) were performing NAKA checking duty near Kenduadih new bridge NAKA point under Jhalda PS in c/w WBLE-2021. During the NAKA checking we found) 01 (one) steel and black colour Hero Passion pro Motor Cycle having Reg. No-JH01BT-1378, chassis no. MBLHA10BSFHF36878, engine no HA10EVFHF37703 was coming from Jharkhand side and we stopped the motor cycle. During checking we found one plastic jarican at the back side of the motor cycle containing approx 20 (twenty) Ltrs. ID liquor. On being asked the above noted person could not produced any valid documents or challan regarding the above noted ID liquor (i.e. 20 Ltrs. (Twenty Ltrs.)). During interrogation he could not give any satisfactory replay regarding reason of carrying ID liquor. On demand he could not produce any valid documents/license in favour of carrying/selling the same. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909. So i seized the above noted articles in presence & direction of SST magistrate under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but could not.

Accordingly I arrested accd. Anoj Kumar Mahto (35) S/O Naidab Mahto of vill- Kancho, P.O- Tutki Nawadhi, P.S- Silli, Dist- Ranchi (JKD) having maintained all formalities after issuing arrest memo. I also offered him for medical check up but he denied at that time.

On return to P.S along with accd. person and all seized articles & put the accd. Person in the PS Lock UP after maintaining all hazat rules and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S to start a specific case against Anoj Kumar Mahto (35) S/O Naidab Mahto of vill- Kancho, P.O- Tutki Nawadhi, P.S- Silli, Dist- Ranchi (JKD) under proper section of law.
