Sir,

In producing here with one arrested accd. Person namely Sandeep Agarwal, aged 56 Yrs. S/O Lt. Pushraj Agarwal of Jhalda (Near Jhalda old PS), PO+P.S- Jhalda, Dist. Purulia brought under arrest with seized articles as (i) one Huyndai Black coloured vehicle, vide its registration no-JH01BM1741, Model-Verna, (ii) One paper box containing 12 (Twelve) bottles of "Royal Stag" whisky where each bottles containing 750 ml which Blended and bottled by "Pernod Ricard India (P) Ltd. at Silika Bottling and blending enterprises LLP, PO - Kamre, Ratu Road, Ranchi-835222". I do hereby lodged this written complain to the effect that on 19/03/2021 at 19:05 hrs. while I along with force, CAPF (CRPF) and SST team (Buddhadeb Mahato IDO of Jhalda-I BDO office FST Magistrate of WBLE-2021, Swarup Panda, ADA Jhalda-I, Dipak Kumar Sahayak of Tulin Gram Panchayet, Cameraman Debasish Baisnab, DEO of Jhalda-I Block office) were performing NAKA checking duty at Tulin Subarnarekha bridge NAKA point under Jhalda PS in c/w WBLE-2021. During the NAKA checking we found one Huyndai Black coloured vehicle vide its registration no-JH01BM1741, Model-Verna was coming from Ranchi side and stopped the vehicle. During checking we found the above noted 12 (Twelve) bottles of "Royal Stag" whisky where each bottles containing 750 ml in the Diki of the said vehicle. On being asked the above noted person could not produced any valid documents or challan regarding the above noted FL (i.e. 12 (Twelve) bottles of "Royal Stag" whisky where each bottles containing 750 ml). During interrogation he could not give any satisfactory replay regarding reason of carrying foreign liquor. On demand he could not produce any valid documents/license in favour of carrying/selling the same. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909. So i seized the above noted articles in presence & direction of SST magistrate under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but could not.

Accordingly I arrested accd. Sandeep Agarwal Aged 56 Yrs. S/O Lt. Pushraj Agarwal of Jhalda (Near Jhalda old PS), PO+P.S- Jhalda, Dist. Purulia having maintained all formalities after issuing arrest memo. I also offered him for medical check up but he denied at that time.

On return to P.S along with accd. person and all seized articles & put the accd. Person in the PS Lock UP after maintaining all hazat rules and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S to start a specific case against Sandeep Agarwal Aged 56 Yrs. S/O Lt. Pushraj Agarwal of Jhalda (Near Jhalda old PS), PO+P.S.- Jhalda, Dist. Purulia under proper section of law.
