In producing here with one arrested accd. namely Muruli Karmakar (40) S/O Taru Karmakar of village Ropo, P.S. Joypur, Dist. Purulia along with seized articles I beg to report that on 03.03.2021 in course of evening mobile duty vide Baglata I/C GDE No-81, Dt-03.03.2021 & CC No-344/21 dt. 03.03.21 myself along with force got a reliable source information at 17:35 Hrs. that one person is selling ID Liquor at Ropo more in his shop under Joypur P.S. After getting information I informed the matter over phone to O/C Baglata I/C under Joypur PS, and left for Ropo more to work out the information. Myself along with Constable/2671 Prasanta Rajak and NVF/901 Shibeswar Kuiry had been to village Ropo more at 18:45 hrs. and found one person was selling ID Liquor. After seeing police party the customers fled away from the spot. On demand the said person failed to produce any valid document for selling ID Liquor. So the above noted accd. person has committed an offence U/S 46-(A)(C)B.E. Act.1909. Accordingly I arrested the above noted accd. person. During arrest as per law all the formalities were duly complied with after issuing arrest memo and informed his relatives for his ground of arrest. During search I found 15 Dil Se Plastic bottle with 600 ml each. ID Liquor. I seized the above noted article after preparing proper seizure list in between 19:05 hrs. to 19:45 hrs. in presence of witnesses duly signed by them as well as the accd. person.

Therefore I pray before you that kindly arrange to start a specific case U/S 46-(A)(C)B.E. Act.1909. against arrested accd, Muruli Karmakar (40) S/O Taru Karmakar of village Ropo, P.S. Joypur, Dist. Purulia.
