The Accused persons are also given out threatened to the complainant at their locality that if we raise any objection then they file false cases against the complainant regarding several matter. Though the Complainant lodged complaint before Joypur P.S. and thereafter lodged complaint before S.P. Purulia on 11.02.2021.
