Sir,

In producing herewith one arrested accused person namely Santosh Mahali (52 yrs) S/o-Late Mangal Mahali of Vill-Selani, PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 14 (fourteen) bottles illicit country spirit "DIL KHUSH" strength 80 up measuring 600 ML. each bottles out of which one bottle taken as sample under proper seizure with label.

I ASI Ananta Kr Dey of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (07/03/2021) at about 16:15 hrs when myself along with C/-2569 Bikram Kalindi, C/-997 Rajkumar Bauri were performed SPI, mobile duty vide Joypur PS C.C. No-1149/21 Date-07/03/2021, as per my source information I reached at Selani village more under Joypur PS and found that the above noted accused person selling country spirit "DIL KHUSH" at his shop Selani More. On seeing Police persons, he conceal his presence at that shop, but on searching we able to trace out him and also to found that 14 (fourteen) bottles of Illicit Country Spirit "DIL KHUSH" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling illicit country spirit liquor to the local people in village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country spirit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 19:05 hrs to 19:20 hrs & label duly signed by him and other available witness after taking 01 bottles of "DIL KHUSH" as sample out of 14 bottles of "DIL KHUSH". During further interrogation he confessed his guilt as such I arrested him today (07/03/2021) at 19:25 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Santosh Mahali (52 yrs) S/o-Late Mangal Mahali of Vill-Selani, PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
