The Complainant above named begs to state as follows:-

1. That the property bearing R.S/Plot no 5428 & 5437 appertaining to L.R Khatian no 3569, 3570 and 3571 measuring 21 decimals is situated at Mouza Upar Kanan within P.S Joypur and under the jurisdiction of this court.
2. That the petitioner is the owner, possessor and title holder of the said property and has been in possession of the same by growing and harvesting paddy. In L.R operation the property has been recorded in the name of the petitioner.
3. That like previous years this year also petitioner has ~~been~~ planted paddy in the said property bearing R.S/L.R Plot no's 5428 & 5437.
4. That on 1.12.2020 the accused persons along with some unknown persons with an intention to commit loss and mischief of the complainant's property armed with Da, sickle bow and arrows etc in their hands criminally trespassed into the complainant's land and began to cut paddy forcibly grown by the complainant.
5. That when the accused persons and others were cutting paddy at that time the complainant and his witnesses who were in the field protested but they were threatened with dire consequences.

and the accused persons assaulted the complainant by fists and blows.

That the accused persons forcibly cut the paddy and took the same with the help of carts which they carried/brought and over head.

7. That the paddy which were cut and removed by the accused persons were grown by the complainant in R.S/L.R Plot 5428 & 5437

8. That there were 25 maunds of paddy which the accused persons took away and the complainant sustained a loss of Rs 15,000/- due to the theft committed by the accused persons.

9. That the accused persons have no right in the land bearing R.S/L.R Plot no's 5428 & 5437.

10. That on the 8.12.2020 petitioner informed/ lodged diary at Joypur P.S being G.D.F no 363 and the police assured that they would take steps. But when step was not taken by Joypur P.S So, the complainant lodged written complaint before the Superintendent of Police, Purulia with a request to take steps.

11. That the accused persons are still remaining in the village.

12. That the petitioner is a poor person and has got no means to proceed the case in his
