Sir,

In producing here with the accused person namely SK Muktar (20 yrs) S/O-SK Nanka of Kantadih, PS-Jhalda, Dist-Purulia brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) having Iron butt, body, barrel, trigger, firing pin etc and 03 (three) rounds live ammunitions, I, ASI Surendra Nath Soren of Baglata IC under Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 11/03/2021 at 22:45 hrs while myself along with C/-522 Ruplal Tudu NVF-901 Shibeswar Kuiry (Baglata IC under Joypur PS GDE No 315 & CC No-394/21 dated-11/03/2021) all of Baglata IC under Joypur PS were engaged in Naka checking duty at Karkara strategic point at Jharkhand Border on Pundag-Bokaro (Karkara) Pitch Road and found the above noted person was coming from Barudih side towards Karkara by Bye-Cycle and on seeing the Naka Checking party he tried to run away. Immediately the checking team apprehended him at Karkara Naka Checking Point. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arms loaded with 02 round live ammunition was kept in his left side of the waist concealed under the shirt. On care full searched another 01 (one) live ammunition was recovered from his left side pocket of wearing full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms and ammunition. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. So, it is reasonable to believe he choose the said place pre-plainly to commit any grievous offence at Pundag and surrounding area . So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my label best to sign the public witnesses but none was available at that time due to night. So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he has violated the provision of Arms Act, 1959.

I therefore pray that a specific case may kindly be started against the accused person namely SK Muktar (20 yrs) S/o-SK Nanka of Kantadih, PS-Jhalda, Dist-Purulia under proper section of law and arrange its regular investigation.
