
In producing herewith arrested accused Swapan Mandal (40 yrs) S/O Lt Naren Mandal of vill – Lori, PS - Kashipur, Dist- Purulia along with seized articles, I beg to report that on 05.03.2021 in course of evening mobile duty myself along with force got reliable source information that one person is selling ID liquor (Chullu) at village Lori in his house under Kashipur PS. Accordingly I along with C/793 Prasanta Patra and C/38 Parbati Charan Mudi, reached at Lori village at about 18.15 hrs to work out the information and when reached in the house of above noted person we found that one person was selling ID liquor (Chullu) in his house. After seeing police party liquor customers fled away from the spot. On carefully searching I found one white colour plastic Jerkin loaded with 10 liter ID liquor (Chullu). On demand the seller failed to produce any valid document in respect of selling ID liquor (Chullu) in his house. On interrogation he disclosed his name and address as noted above. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act and arrested him, during arrest the ground of arrest was duly informed, issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized ID liquor (Chullu) 300 ml taken out in a separate container as sample with sealed & labeled. The whole process has been completed in between 18.55 hrs. to 19.25 hrs. I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law u/s 46(A)(c) B.E. Act 1909 against arrested accused Swapan Mandal (40 yrs) S/O Lt Naren Mandal of vill – Lori, PS - Kashipur, Dist- Purulia and arrange for its investigation.


