- 1. That your petitioner Bandana Goswami is the legally married wife of Sashikanta Lohar s/o Sadhu-daran Lohar of Vill.Punura, P.S. Kenda, Dist.Purulia within the jurisdiction of the Honourable court.
- 2. Phat on 2.03.2019 accused Sashikanta Lohar abducted your petitioner for the purpose of illegal sextual inter course and by the intervention of local people and villagers aforesaid accused married your complainant at the Kalyaneswari Mandir and finally the marriage was register on 29th day of May, 2019 before the Marriage register, Raghumathpur, Purulia.
 - 3. That since after 2.3.19 petitioner reside at the house of accused as husband and wife and marriage has been consumated.
 - 4. That after few days from the date of marriage your complainant has been subjected to physical as well as mental torture by the husband Sashikanta Lohar, father in law Sadhucharan Lohar and mother in law Kabita Lohar. They use to assault your complainant by demanding

dowry amount of Rs.50,000/- and as and when your complainant demanding her father is a very poor man as such they used to stop food, cloth, medicine and other facilities and driven out from the house.

- 5. That in this regard for physical assault your complainant informed the matter before the Police station on 29.9.2019 and by the intervention of local people present matter was allihethy composed and petitioner was taken to her father's house and a criminal case in u/s. 323/325 T.P.C. has been started against the accused persons.
- persons entered into the father's house of your petitioner started to assault your petitioner and after assault they snacked the original marriage certificate and started incident on 15.12.2020 petitioner increase informed the matter before the P.S. against the all accused person but all in vain.
- 7. That as and when no action was taken for physical as well as mental torture by the accused persons, your complainant informed the matter to the S.P.Purulia on 3.1.2021 but till date nothing has been done.
