Respected Sir,

I, SI Subhendu Sekhar Bera S/o- Haricharan Bera of Vill- Nunia P.O- Gidhni P.S – Jamboni, Dist- Jhargram, now posted as SI of Police at Kenda police station Dist- Purulia producing herewith one arrested accused person namely Bahadur Mudi (50 yrs), S/o – Lt. Ghaltu Mudi of Vill- Charandih, P.S – Kenda, Dist- Purulia with seized articles i.e. 1) Approx 15 Ltrs. ID liquor contain in a yellow colour plastic Jarican 2) Approx 1 (one) Ltr. ID liquor as sample which is collected from seized articles in SI No-01 & kept in a bottle 3) 07 (Seven) Pcs. steel glasses which were seized under proper seizure list.

I beg to submit that today (05-03-2021) during special raid duty acting of a secret source information myself along with C/1492 Dilip Chandra Gorain and C /1524 Krishna Chandra Mahato of Kenda PS conducted raid in the house of the above noted accused person at about 17.55 hrs and found that he was keeping and selling of ID liquor at his house to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused persons. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) Approx 15 Ltrs. ID liquor contain in a yellow colour plastic Jarican 2) Approx 1 (one) Ltr. ID liquor as sample which is collected from seized articles in SI No-01 & kept in a bottle 3) 07 (Seven) Pcs. steel glasses under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the fact and circumstanced I therefore pray that a specific case may kindly be start against Bahadur Mudi (50 yrs), S/o – Lt. Ghaltu Mudi of Vill- Charandih, P.S – Kenda, Dist- Purulia as per proper section of law.

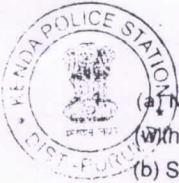
