Sir,

In producing here with one accused person Lakhikanta Mahato (60) S/O Lt. Chhutu Lal Mahato of village Jitujuri Majpara PS- Mandabazar District Purulia along with following seized articles viz-

- 1) 22 (Twenty two) Ltrs ID liquor within a Jarikane
- 2) 12 pieces plastic glass

I S.I. Mahadeb Rana of Mandabazar PS do here by lodged a complaint against accused namely Lakhikanta Mahato (60) S/O Lt. Chhutu Lal Mahato of village Jitujuri Majpara PS- Mandabazar District Purulia to the effect that today (05.03.2021) at 19:35 hrs. I received a telephonic information from a reliable source that one Lakhikanta Mahato (60) S/O Lt. Chhutu Lal Mahato of village Jitujuri Majpara PS- Mandabazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in G.D vide Mandabazar PS GDE No- 195 Dtd 05.03.21. I informed the matter to O/C Mandabazar PS and as per order of O/C Mandabazar PS myself along with C/1183 Sabitri Kundu NVE/366 Tapas Kr Mahato rushed to the spot for raid by Govt. vehicle. At about 20:15 hrs myself along with force reached at Jitujuri village and held raid in the house of Lakhikanta Mahato (60) S/O Lt. Chhutu Lal Mahato of village Jitujuri Majpara PS- Mandabazar District Purulia and found that said house owner selling ID liquor at his own house and seeing the police party some persons fled away and said Lakhikanta Mahato tried to conceal himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Lakhikanta Mahato (60) S/O Lt. Chhutu Lal Mahato of village Jitujuri Majpara PS- Mandabazar District Purulia as per law and arrange for its investigation.
