1, SI Dipankar Sarkar, O/C, Manbazar PS do hereby lodge complaint as Suo-motu against unknown 40/50 miscreants to the effect that, today (16.03.21) from 14:00 hrs, a permitted political program of Hon'ble MP Shri Abhishek Banerjee was scheduled to be held at Jitujun village, Ma chandi football ground besides Manbazar Purulia pitch Road under Manbazar PS, Dist Purulia which was permitted up to 18:00 hrs. At about 15:20 hrs when the speech of Hon'ble MP ended and part of the gathered crowd of about 15:000 was dispersing, suddenly we, the venue duty officers noticed concentrated gathering around a vehicle styled as Rath (having Reg No UP 17 AT 6233) and shouts around it opposite to the venue on Manbazar-Purulia road. On duty officers along with available force rushed to the spot apprehending breach of peace and rescued the driver (Farman Ali s/o Aisan Ali of Shyamnagar road, Gadda Wali Masjid, Goli No – 3, PS- Nisari, Dist Meerut, U.P) apprehending possibility of disturbance. Subsequently it was noticed that the front windshield was broken and some of the faces of political leaders printed upon the vehicle walls were defaced with mud. To avert any untoward incident and further loss of property, the driver was taken into safe custody who was hackle by those peoples and was escorted to Manbazar PS along with seized Rath and a police escort vehicle.

As such, returning to the PS I started a case Suo -motu against unknown 40/50 persons, vide Manbazar PS Case no 14/21 dated 16.03.2021 U/S 341/323/427/34 IPC and directed SI Mahadeb Rana for its investigation.
