Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accused person namely Kajal Mondal (42 Years) S/O-Lt. Ananda Mondal of Vill-Benipur, PS-Neturia, Dist-Purulia with seizure of 20 pcs Sealed bottles of Dil Se Country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (05.03.21) while I, ASI Dibyendu Mahato, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-231 Dt. 05.03.21 and acting on source information after consulting you at about 18:35 hrs reached at Jhanka More and held raid in the shop (Shaded by straw) of Kajal Mondal (42 Years) S/O- Lt. Ananda Mondal of Vill-Benipur, PS-Neturia, Dist-Purulia and found that he was keeping / selling liquor which were kept in his shop, on demand Kajal Mondal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 20 pcs Sealed bottles of Dil Se Country spirit containing 375 ml which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Kajal Mondal (42 Years) S/O- Lt. Ananda Mondal of Vill-Benipur, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1140 Dayamoy Mahato (2) C/1304 Dhananjoy Mondal and (3) NVF/636 Chutu Singh all of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Kajal Mondal (42 Years) S/O- Lt. Ananda Mondal of Vill-Benipur, PS-Neturia, Dist-Purulia under proper section of law.
