Respected Sir,

In producing herewith one accused person namely Sunil Kumar Mahato (34 Years) S/O- Shyamsundar Mahato of Parbelia Amdanga, PS-Neturia, Dist-Purulia with seizure of 25 pcs Sealed bottles of Dil Se Country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (06.03.21) while I, SI Kalyan Kumar Sakha along with force were performing special mobile duty vide Neturia PS GDE No-272 Dt. 06.03.21 and acting on source information after consulting you at about 12:25 hrs reached at Parbelia Bazar and held raid in the hotel styled as "Suman Hotel" of Sunil Kumar Mahato (34 Years) S/O-Shyamsundar Mahato of Parbelia Amdanga, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Sunil Kumar Mahato failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 25 pcs. Sealed bottles of Dil Se Country spirit containing 375 ml each which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Sunil Kumar Mahato (34 Years) S/O- Shyamsundar Mahato of Parbelia Amdanga, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1224 Gajan Murmu and (2) C/480 Uttam Bauri both of Neturia PS accompanied me.
