Sir,

In producing herewith one arrested accused namely Md. Arif Ansari (31) S/O- Ahmad Ansari of Vill-Makpito, PO-Karharbari, PS-Giridih Mufassal, Dist-Giridih, Jharkhand with one improvised country made pipe gun (iron made) approx 20 cm in length, iron butt, barrel, trigger, firing pin, hammer etc. along with 01 round live cartridge (marked as 8MM KF) to the effect that today on 07.03.2021 at 15:15 hrs while I, SI Abhijit Das along with force C/1327 Samik Banerjee, JC/1376 Budhuram Tudu and HG/1810 Suryakanta Singh were performing anti crime Naka checking duty at Dishergarh Ghat vide Neturia PS CC No- 584/2021 Dt. 07.03.2021. During Naka checking duty found that the above noted person was coming from Barakar side by a bicycle and he suddenly stopped about 30/35 meter away from the Naka point and he stayed there for a long time but neither returning back nor crossing the Naka point and his movement found suspicious. When I along with force moved towards the above noted person, he tried to flee away along with his bicycle from there. Anyhow we managed to apprehend the above noted person and on being asked he disclosed his identity as noted above but he failed to give any satisfactory answer about his presence at that place. Searched the above noted person very carefully in presence of local people and recovered one improvised country made pipe gun (iron made) approx 20 cm in length, iron butt, barrel, trigger, firing pin, hammer etc. loaded with 01 round live cartridge (marked as 8MM KF) from his exclusive possession, which was concealed in his waist and on being asked he stated incoherent statement in respect of his presence at the area at that time. There was every reason to believe that the accused had come down in the area with a view to commit crime by using the illegal fire arms or selling the fire arms. On demand, he failed to produce any valid documents/license in respect of the said arms & ammunitions. Accordingly, I seized and labeled in between 15:55 hrs to 16:25 hrs one improvised country made pipe gun (iron made) along with 01 round live cartridge (marked as 8MM KF) and one bicycle from his possession under proper seizure list duly signed by the accused person and witnesses. I requested the available local people as witness during seizure but most of the people left the place but one namely Rupesh Ball S/O- Lt. Madhab Ball of Parbelia Bazar, PS-Neturia, Dist-Purulia signed as witness in seizure list and arrested the above noted accused person at 16:30 hrs after observing all the guidelines of Hon'ble Apex Court of India, Hon'ble High Court Calcutta, N.H.R.C & W.B.H.R.C.

Under the above fact and circumstances it is reasonably believe that arrested accused person have committed a serious offence and he is liable for an offence punishable U/S- 25/27 Arms Act.

Therefore, I pray that a specific case may kindly be registered against one Md. Arif Ansari (31) S/O-Ahmad Ansari of Vill-Makpito, PO-Karharbari, PS-Giridih Mufassal, Dist-Giridih, Jharkhand under proper section of law and arrange its investigation.
