Man No. 113150, S/o Lt Piru Hari, resident of Amdhawrah, Parbelia Colliery deputed to work as Security Guard at C.H.P, Parbelia Colliery in II Shift (form 4 pm to 12 am) on dated 13.03.2021. At about 10 pm on that day one Sri Kalyan Bouri, S/o Matla Bouri residing at Uppardhawrah, Kalimela, Parbelia Colliery under Neturia P.S, entered into the colliery premises with an intention to pilferage coal and iron materials. Sri Lakhu Hari obstructed him to do so, then Sri Kalyan Bouri had beaten him badly as a result Sri Hari immediately admitted at Sanctoria Hospital for his treatment.
