Sir,

I, BISWAJIT NATH, S/O. Sri CHITTARANJAN NATH, residence of village parbelia, P.O + P.S- Neturia, Dist-Purulia, W.B. hereby inform your kind office that I am the Soul proprietor of Rudranil Processing & Filter Material supplier, situated at River side, Parbelia Village, P.O+P.S- neturia, Dist - Purulia, W.B on 27/03/2021, at about 9.08 PM, a call from the night guard namely SUNIL MARDHI S/O - SANTOSH MARDHI of my above noted firm, informed me that 1. MADHU KARMAKAR S/O- Lt. HIRALAL KARMAKAR, resident of Kamarpara, parbelia, P.O + P.S - Neturia, dist - Purulia, W.B. 2. AKASH MURMU S/O - Lt. CHAND MURMU, resident of Debidanga, Parbelia, P.O+P.S - Neturia Dist- Purulia, W.B. 3. SANJU HEMBRAM S/O- LAL HEMBRAM resident of Debidanga, Parbelia, P.O+P.S-Neturia, Dist- Purulia, W.B. 4. CHAMPA MURMU S/O. NUNULAL MURMU, resident of Kamarpara, Parbelia, P.O+P.S - Neturia, Dist- Purulia, W.B. 5. ASHESH HEMBRAM S/O. SIBU HEMBRAM, residence of Kamarpara, Parbelia, P.O+P.S - Neturia, Dist- Purulia, W.B., had forcefully enter into the firm premise, and started to assault KARTIK TANTUBAI S/O - Lt. SARAT TANTUBAI, who is opposing their entrance in the firm premise, and they also demanded the money from said Kartik Tantubai, where he informed that already payment has been made to the labours and he have only 4000/- rupees for diesel purchase, then the above named person snatch the amount of Rs. 4000/- from said Kartik Tantubai, and thereafter put fire in the stock of Plastik Bag and tripal and forcefully abducted said Kartik Tantubai with them. After getting information I along with Sourav Tantubai, Pradip Tantubai, rush to my firm within 20 minutes and found that my firm was on fire where the stock of plastic bag and tripal i.e the total number about 30,000 bags of price Rs, 5/- per bag i.e. Rs. 150000/- (One lakh fifty hundred only) and 15 tripal @ Rs. 5200*15= 78000/- was burnt into ashes. I also found said Sunil Mardhi who hid himself from them and also the eyewitness of entire incident. I along with some villagers went to search for Kartik Tantubai at that time, but failed and informed neturia police station and police rescued him and get him admitted at harmadiah CHC on 27/03/2021.

It is therefore requesting before your kind office, to take necessary action against the above named person who forcefully entered into my firm premise and snatch the amount from my night guard who also abducted by them to kill and set fire in my firm causing loss of huge amount to me.
