Today acting upon a source information, I along with officers & force were out for holding special drive against ID liquor as per order vide Puncha PS GDE No.-183 & 184 dtd-04.03.21 and CC No 369 & 370 dtd. 04.03.21 I along with officers and force including lady Constables reached at Vill Dhengagora, under Puncha PS, keeping the govt vehicles (WB56B/4919 & hired vehicle JH09M/3568) away from the village we entered into the village to hold raid at the house of Sufal Mandi, S/O Jogeswar Mandi who was said to be unauthorised seller of ID liquor. I along with the team entered his house and found jar canes of ID liquor. When we went for holding the raid, Sufal Mandi, S/o Jogeswar Mandi and his wife obstructed us to enter his house. Inspite of that we entered his house and saw that a huge amount of illicit liquor was under manufacture and few jar canes were filled up with manufactured illicit liquor. While we started the raid by taking the illicit liquor under our custody and tried to detain them, suddenly with his loud shout he called his associates to assemble who were all roaming nearby. Then I identified them as, 1. Sufal Mandi (44 yrs approx), 2. Gurudas Mandi (25 yrs approx), both S/o Jogeswar Mandi, 3.Bifal Mandi(42 yrs approx), s/o - Lt Sahebram Mandi, 4 Budhan@Budhu Mandi(46 yrs approx), s/o Gane Mandi, 5. Deben Mandi(42 yrs approx), s/o Not known, 6. Sabitri Mandi(39 yrs approx), w/o- Sufal Mandi, 7. Protima Mandi(45 yrs approx), w/o-Budhan@Budhu Mandi, and ten (10) no.s of females and 20 others(male) all of village Dhengora, PS-Puncha, Dist-Purulia joined them and suddenly used force to protest against the raid and in the mean time they surrounded us from all the directions and being equipped with lathi, bamboos, stones, brick bats, iron rods, axe, tabla etc assaulted us. Being in police uniform I along with other officers and force tried to stop them but they did not paid heed and continued their assault. The mentioned people assaulted us with the above mentioned means and as a result of which I along with PSI Sandip Pal, ASI Anup Roy, C/-214 Siddhartha Mandal, NVF/685 Joydeb Mahato sustained grievous injury on our person and refrained us from performing govt duty. The mentioned people were heard saying "aaj sala police ke merei felbo jaate bhobisyote kono dino amader mod toiri o bikri te badha na dite pare.... Mere fel sala der ke..." and in the same time were pelting stones continuously with a view to assault us. Somehow we escaped from the situation keeping the jar canes at the spot. The whole incident took place in between 19.15 to 19.40 hrs.

Under such situation I pray that an FIR may kindly be lodged u/s-143/341/186/332 /333/353 IPC against all the mentioned persons.
