

In producing herewith one arrested accd. person namely Ananda Mahato (29) 874 Satrughana Mahato of Vill- Pakbirrda, PS- Puncha, Dist- Purulia with seizure list and seized articles.

I beg to submit that today (10.03.2021) I was detailed to perform mobile duty in PS area along with force i) C/1479 Anup Mahato & ii) C/1091 Suroj Mahato both of Purulia (M) PS & Purulia (M) PS C.C. No 629/2021 Dt. 10.03.2021 and GDE No 463 Dtd. 10.03.2021. During my mobile duty, I received a secret tip off an illegal possession of huge amount of Country spirit and foreign liquors. Subsequently, I informed you and as per your direction, I rushed to the Dhaba styled as "Trimurti Dhaba" under this PS and arrived at the spot and as per indication conducted raid in the Hotel of Ananda Mahato (29) 8/0 Satrughana Mahato of Vill- Pakbirrda, PS- Puncha, Dist- Purulia at 19:25 Hrs. During the raid I found supra noted person in that Dhaba who introduced us as shop keeper. On asking his identity, he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit and foreign liquor for selling illegally in his Dhaba so that he could gain more amount from the selling of foreign liquors styled as Officers choice/3x Rum, and Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said of foreign liquors / Country Spirit at his Hotel. Subsequently, I seized i) 20 bottles of country spirit styles as Dilkhush containing 600 mls (total amounted Rs-1200/-) ii) 01 bottles of foreign liquors styles as M/C Dowell No-I RUM containing 375 mls (amounted Rs-320/-) iii) 02 bottles foreign liquors styles as M/C Dowell No-I RUM containing 180 ml each [amounted Rs- 256/-), iv) 02 bottles foreign liquors styles as Officers choice containing 180 ml each (total amounted Rs-280/-). & (v) 06 Bottles King Fisher containing 600 ml (Total amounted Rs-780/-) From which 01 bottle of country spirit styles as Dilkhush containing 600 mls, 01 bottles of foreign liquors styles as M/C Dowell No-I RUM containing 375 mls. 01 bottles of foreign liquors styles as Officers Choice containing 180 mls, 01 bottles foreign liquors styles as King Fisher containing 600 mls were taken from those 31 bottles as samples under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized those articles and sealed properly and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Ananda Mahato (29) s/o Satrughana Mahato of Vill- Pakbirrda, PS- Puncha, Dist- Purulia committed offence u/s 46 A (c) cf Bengal Excise Act. 1909 for unauthorized possession for selling of foreign liquor/ Country Spirit in his Dhaba

Under the fact and circumstance kindly take necessary lawful action against Ananda Mahato (29) s/o Satrughana Mahato of Vill- Pakbirrda, PS- Puncha, Dist- Purulia.
