The humble petition of the complainant Hajina Bibi Most respectfully beg to state:

That she is the permanent resident of village Hutmura under purulia (M) police station within the jurisdiction of your Honours court.

The complainant on 26-01-2021 was in her house. On the same date in the morning some minor boys of the accused persons assaulted the minor boys of the complainant but the said incident was amicably settled. On the same day i.e. 26-01-2021 all the accused persons at about 10 A.M. After forming an unlawful assembly and armed with iron rod, stone e.t.c illegally trespassed into the courtyard of the complainant and restrained her and crying मात्रमानाप्तत, कार्रमानाप्तत assaulted her by fist, blows and kicks seriously when she fell down accused sk. Abul assaulted on her head by Iron rod and the women accused persons took one silver chain and golden Ear rings and nose Nasika from the possession of the complainant. The accused persons also assaulted minor khusnasib and minor sk. Sail and some others. The complainant cried loudly when the witnesses came and saw the incident. It is mentioned that at the time of incident the husband of the complainant was in his place of work but on getting phone call about the incident from sk. Amanatulla who took the injured complainant to purulia sadar Hospital, direct went to purulia sadar Hospital and arranged for her treatment. The doctor attending the injured admitted her and took all arranged for her treatment. Though the complainant was discharged thereafter but her treatment is still going on. The cost of the stolen articles will be about Rs/- 30,000 (thirty thousand). The accused persons also broke down the water tap.

After the occurrence information was lodged in purulia (M) police station but the police officer did not start any case for which a complainant



was send to the officer in charge of purulia (M) police station on 01-02-2021 by registered post and thereafter the copy of the complaint was submitted before the superintendent of police purulia on 20-02-2021 but till now no case has been started against the accused persons for which your petitioner has filed this complaint before your Honour and prays that the complaint may kindly be sent to the officer-in-charge of purulia (M) police station with direction to treat the petition as a F.I.R. and to investigate and report.
