In producing here with arrested accused persons namely 1) MD. Sultan (45) s/o Lt. Md. Soleman of Vill- Chapuri, PO- Anara, PS- Para, Dist- Purulia & 2) Abdul Jaffar Sk (45 yrs) s/o Lt. Samsuddin Sk of Vill- Keshabpur, PO- Punishol, PS- Onda, Dist- Bankura and seized articles (1) one country made pipe gun length approx. 9 inch with Iron butt & one round live ammunition (2) one iron rod, Length approx. 3 ft. (3) One Tabla (Tangil) with wooden butt approx 4 ft. in length & (4) one sword length approx 2.8 Ft. lodged complain against them and 04 others to the effect that on 20.03.2021 at about 22.45 hrs received a credible tip that a gang of dacoits being armed with deadly weapons like firearms assembled in an open deserted place near a shop of Aswini Mahato at Purda Village under Purulia (M) PS and they were preparing themselves for committing dacoity at Ghonga village side. This matter was informed to I/C Purulia (M) PS subsequently and noted the information down to the GDE of Purulia (M) PS GDE No 957 Dated 20.03.2021. On getting the tip off as per your kind order I was accompanied with force namely i) C/967 Basudeb Sing Mura, ii) C/253 Arabinda Mallik & JCO/1397 Shyamal Hembram all of Purulia (M) PS vide CC No. 722 dated 20.03.2021 immediately proceeded to the anticipated place of assembly to work out the information and reached near the shop of Aswini Mahato at 23:40 Hrs leaving the Police vehicle No- WB 56C 5423 and started to proceed for the anticipated place on foot. At 23.55 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 5/6 persons assembled in the open land in the dark side of a tree and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to detain in rounding up only 02 (Two) of them at 00.05 Hrs dated 21.03.21 while the rest 04 managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered one country made pipe gun length approx. 9 inch with Iron butt & one round live ammunition from the back side waist of Abdul Jaffar Sk (45 yrs) S/O Lt. Samsuddin Sk of Vill- Keshabpur, PO- Punishol, PS- Onda, Dist- Bankura with loaded one round live ammunition then I unloaded gun with proper care and caution and one sword length approx 2.8 Ft. from the left side waist of accused MD. Sultan (45) S/O Lt. Md. Soleman of Vill- Chapuri, PO- Anara, PS- Para, Dist- Purulia and also searched the place of assembly with torch light and recovered one iron rod, One Tabla(Tangil) with wooden butt approx 4 foot in length. Then in between 00.05 hrs to 00.45 Hrs on 21.03.21 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) one country made pipe gun length approx. 9 inch with Iron butt & one round live ammunition (2) one iron rod, Length approx. 3 ft., (3) One Tabla(Tangil) with wooden butt approx 4 ft in length & (4) one sword length approx 2.8 ft from the place of assembly under proper seizure list as well as labelled duly signed by apprehended persons and witnesses as
