I, the undersigned, begs to submit that marriage was held on 13/04/2015 with Subrata Sen, S/O Jyoti Prakash Sen of Bhatbandh Parthardih Para, Gel Church Road, Near Atlas Club, P.O- Purulia, PS-Purulia(T), Dist-Purulia at Gel Church Ranchi Road, Purulia, as per out rites and customs, be it mentioned here that at the time of marriage many valuable gifts were given to my husband as per their demand. After a few months of marriage came to know that my husband used to take wine regularly, under influence of wine he used to insult me in filthy language on many occasions I tried to make him understand not to take wine but he ignored the same. He always used to come home after taking wine and pick up hot altercation with me. I tolerate all these on 17.02.2017 my son Chris Sen took birth, but my husband did not take my care of me and my son, on the other hand he used to demand money from me to fulfil his bad habit of wine and other druge, since I am a constable of West Bengal Police. It become impossible for me to go out of home. My father in law and other in law used to support their son instead of forbid him. In this way of considerable period of almost 06 years has been passed but he did not change his nature. on many time he kickme out of his house in the night after assaulting me. At present on 13/01/2021 he took my son forcibly and kick me out of his house. I went to my father's house. He refused to give my minor son. I informed the PS here he accepted his guilt and returned my son. At present I am residing at my father's house with my son.

My ill fate did not stop there, at present he is giving me various threats. He used to obstruct my way. When over I used to go any where. He used to demand money every where as he do nothing. He is able bodied persons. But not carring the livlihood. In this way my husband is causing physical and mental torture upon me.

It is thereafter a kind request before you to take necessary legal step against my husband and in law members to save me any my minor child.
