Sir,

In producing herewith the accd. person namely Md. Chhotu @ Tahir (30) s/o Md. Siraj of Digudipara, Ward no.08, PS Purulia (T), Dist. Purulia in custody under proper memo of arrest along with related documents and the following seized articles (1) one improvised country made single barrel iron made firearm butt coated with wood having barrel length of 7.6 cm, body length 10.05 cm and butt length of 7.5 cm with no trigger guard and (2) one live cartridge having length of 7.5 cm on which OK, 04 and 77 is imprinted, I SI Suvajit Nandi of Purulia (T) PS do hereby lodge a complaint against the above noted accd. person to the effect that today i.e., on 11.03.21 at about 22:35 hrs while myself alongwith C/2366 Anupan Das, C/3192 Tarun Sahoo, C/2653 Nirmal Mahato & C/2345 Debsankar Barik in uniform were performing NAKA checking at Telkalpara Naka point on NH-314 placed in c/w General Election to WBLA-2021 vide Purulia (T) PS CC no.1006/21 dtd.11.03.21, at that time my accompanying force noticed a person who was proceeding towards Telkalpara side from Suirulia side on foot in suspicious manner. On seeing the Police party the said person tried to flee away back towards Surulia side. As such my accompanying force chased him and could able to nab him and brought him to the NAKA check post. At such dead hours none of the public was found to witness the incident. We detained him and disclosed our identity before him and told him that he is needed to be searched as there is every ground of suspicion over his movement. On interrogation he disclosed his identity as Md. Chhotu @ Tahir (30) s/o Md. Siraj of Digudipara, Ward no.08, PS Purulia (T), Dist. Purulia. Hence I issued notice to him and asked him to search us before he is being searched by us. He refused to search our person but agreed to get searched by me.

Accordingly, I conducted search in between 22:45 hrs and 22:55 hrs and found one improvised country made firearm loaded with one round of live ammunition kept in the right side of the waist of the said person. No personal property was found from his person. On demand he failed to produce any valid documents/licence in support of carrying/possessing the seized improvised country made firearm. I unloaded the live

ammunition safely from the said firearm and in between 22:45 hrs and 23:15 hrs I seized (1) one improvised country made single barrel iron made firearm butt coated with wood having barrel length of 7.6 cm, body length 10.05 cm and butt length of 7.5 cm with no trigger guard and (2) one live cartridge having length of 7.5 cm on which OK, 04 and 77 is imprinted under proper seizure list in presence of Police witnesses duly signed by them and thumb impression of the accd. person and supplied a copy of the seizure list to the accd. person duly acknowledged by him. I also packaged, sealed and labelled the seized articles in presence of witnesses duly signed by them. Thereafter I arrested the accd. person namely Md. Chhotu @ Tahir (30) s/o Md. Siraj of Digudipara, Ward no.08, PS Purulia (T), Dist. Purulia as per the procedure laid down in CrPC maintaining the NHRC guidelines and the directions of Hon'ble Apex Court under proper memo of arrest. I informed him the grounds of his arrest and supplied a copy of memo of arrest to him duly acknowledged by him.

Therefore, as the above noted arrested accd. person has committed an offence which attracts sec. 25/27 Arms Act 1959 I am submitting this complaint against the accd. person namely Md. Chhotu @ Tahir (30) s/o Md. Siraj of Digudipara, Ward no.08, PS Purulia (T), Dist. Purulia with a request to initiate a specific case against him for proper investigation and subsequent legal action.
