





- 2. That on the other hand the accused persons are also residing within the jurisdiction of this Ld. Court.
- 3. That on 31.12.2020 at about 8:00 a.m. in the morning the Petitioner went to offer Puja at the near temple situated of her matrimonial house. At that time the accused persons namely Kishanlal Budhiya S/o Late Omkarlal Budhiya, Ashadevi Budhiya W/o Kishanlal Budhiya and Preeti Budhiya D/o Kishanlal Budhiya all resident of Srivatika, Srilal Kothari Shiblal



Lane, P.S. Purulia(T), Dist-Purulia, Pin-723101, West Bengal restrained the Complainant from offering Puja. When the Complainant asked the reason, they replied that as the Petitioner belongs to low caste she will not be allowed to offer Puja in the said Temple. When the Complainant protested the said act. The above named all the accused persons they abused the Petitioner with filthy language and spitted at her and threatened her that she will be ousted from the area as she belongs to low caste. Many people assembled at the spot at the time of this incident all the accused persons intentionally insulted the Petitioner in presence of all of them. That all the accused personstold the Petitioner "Gnarra 1/2 of Those area." "and further stated" can see a specific of the state of

" hearing the hue and cry, the family members of the Petitioner and the persons of the locality also assembled at the spot and all the accused persons with their common intention continued to pass the derogatory remarks towards the Complainant raising the issue of caste and harassed the Petitioner in presence of all. That the accused persons also make obscene gesture towards the Petitioner and threatened the Petitioner that she will be compelled to leave the area as she belongs to low cost as per their opinion. Such type of behaviour of the accused person and making derogatory remarks regarding the issue of caste hurt the feelings of the complainant and lower down the dignity of the complainant in the presence of all. That the matter was reported to Purulia(T) P.S. but the police have taken no action against the accused persons as such the complainant filed a complaint before the Superintendent of the Police for giving proper order and direction, to the O/C Purulia(T) P.S. but till today the police did not take any steps against the above named accused persons. So finding no other option Your Petitioner is filing this Petition u/s 156(3) CrPC against the accused persons before Your Honour.
