To The Inspector – in charge Raghunathpur P.S.

Sir,

In producing herewith the arrested accused person namely Samser Ansary @ Gera (28) S/o Sayed Ansary of Vill.- Dumurhir, PS – Neturia, Dist.- Purulia alongwith seized and labeled articles one iron made improvised country made one shutter fire arms and one round live cartridge.

To the effect that on 08.03.2021 I, SI Indrajit Sarkar along with C/1010 Samir Paramanik and C/1488 Ramjan Ansary of Raghunathpur PS were engaged in Naka Checking Duty at Kargali Ghat vide Raghunathpur PS GDE No 366 dtd 08.03.2021 and CC No. 659/2021. At about 20:15 hrs one person was coming from Kargali side to Chelliyama by foot. On seeing the police party of Naka Checking the above noted person tried to flee away and we able to apprehend him after long chase. On being suspicion I searched the said person and found one iron made improvised country made one shutter fire arms loaded with one round live cartridge, length of Barrel is approx 08 (Eight) inch, Body is approx 08 (Eight) inch and the Butt is approx 06 (Six) inch along with trigger and fire pin was kept in his right side of the waist under his full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms and ammunition. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. So, it is reasonable to believe he choose the said alone place pre-plainly to commit any grievous offence during Assembly Election period. So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as the accused person and also labeled the same. I tried my label best to sign the public witnesses but in alone place, so none present there. So I unable to put signature of any public witnesses on the seizure list. Hence, I arrested him issuing memo of arrest as he is violated the Arms Act 1959.

I therefore pray that a specific case may kindly be started against the accused person namely Samser Ansary @ Gera (28) S/o Sayed Ansary of Vill.- Dumurhir, PS – Neturia, Dist.- Purulia under proper section of law and arrange its regular investigation.
