Sir,

With due respect I, SI Tufan Kr Dawn of Raghunathpur PS, do hereby lodge complaint against (1) Sri Bibekananda Bouri, Candidate of BJP Party of 246/Raghunathpur AC, (2) Kartik Tewary, Election Agent of BJP Party of 246/Raghunathpur AC, (3) Baneswar Mukherjee, Blockdanga, Raghunathpur, (4) Falguni Mishra, Dhobapara, Raghunathpur, (5) Swapnesh Das, Tantipara, Raghunathpur (5) Ujjwal Banerjee of Barikbandh, Raghunathpur and 500 others to the effect that today, i.e., on 25.03.2021, there was a proposed programme of BJP, as received by this PS, where Hon'ble MP Sri Manoj Tewary and film actor Shrabanti Chatterjee will do a road show at Kashipur PS area and in this regard it was scheduled that VIP will reach by Chopper at the Helipad situated near Nag Showroom under PS Raghunathpur.

But from different source, information received that Advocate Bibekananda Bouri, contesting candidate of BJP will hold the road show at Raghunathpur Town also, with M.P. Sri Manoj Tewary and Shrabanti Chatterjee. According to R.O. Raghunathpur AC the road-show is not having any permission and, in this regard, different phone calls from different political parties and media personnel, were received. All started pursuing the matter strongly so that, is at all there is any road show without any permission, that need to be stopped at any cost and legal action to be initiated.

On receipt of the information, IC Raghunathpur PS, Sri Sanjoy Chakraborty along with available force and officers immediately reached at Helipad and tried to pursue the candidate of 246/Raghunathpur AC Sri Bibekananda Bouri and his election agent Kartick Tewary as well as local leader Baneswar Mukherjee, for not taking out any road show procession without permission. The information was passed to RO 246/Raghunathpur AC and Hon'ble General Observer of 246/Raghunathpur AC that has been clearly instructed without permission no road show will be allowed. In the meantime, IC Raghunathpur called SDPO, Raghunathpur Sri Durbar Bandyopadhyay to intervene into the matter. Necessary communication was made to RO 246/Raghunathpur AC i.e., SDO, Raghunathpur, Hon'ble General Observer of 246/Raghunathpur AC and Hon'ble Police Observer over phone.

Subsequently SDPO, Raghunathpur and IC Raghunathpur PS have further requested candidate of 246/Raghunathpur AC Sri Bibekananda Bouri and his agent as well as Baneswar Mukherjee but candidate vehemently denied to agree to the directions and behaved in a very adamant manner.

Lastly, from Raghunathpur Blockdanga party office road show was started and by this time RO 246/Raghunathpur AC Miss Divya Murugesan, I.A.S. SDO, Raghunathpur directed over phone that this is a non-permitted road show and as per instruction of Hon'ble General Observer it should be stopped.

Subsequently, SDPO, Raghunathpur and IC Raghunathpur PS once again requested star campaigners and contesting candidate to obey direction of Hon'ble Observer 246/Raghunathpur AC but they did not pay any heed and continued the rally at about 13:10 hrs. After crossing 300 – 400 meters, in front of Raghunathpur Police Station at about 13:55 hrs, police tried to pursue the matter not to proceed procession any further as it will attract legal provision but surprisingly they did not listen to this also and in furtherance the guard rails were dislocated and damaged and started man-handling police personnel by virtue of which IC Raghunathpur PS Sri Sanjoy Chakraborty received injury on his chest and back but police authority never used any force and further pursued the matter with organized not to proceed the road show further. Subsequently road show was stopped and the followers were dispersed.

The organizers by this way formed an unlawful assembly, proceeded with the procession in furtherance of their common intention without any prior permission from the competent authority, disobeyed the directions of a public servant, who were on duty with full uniform, man-handled the public servant and thereby obstructed to discharge their duties and caused injury to IC Raghunathpur PS Sri Sanjoy Chakraborty. They also obstructed the public way by taking out procession / road show without permission from the competent authority and damaged public property and thereby committed an offence U/S 147/149/323/325/186/353/188/308/283 IPC, 3 PDPP Act and 9 MPO Act.

With the help of available officer and force I arranged to shift IC Raghunathpur PS Sri Sanjoy Chakraborty to Raghunathpur S.S. Hospital and he is now admitted there in critical conditions.

This is further to state that with the available officers and force and with the help of local people identified the accused persons who participated in the road show and man-handled the police person, as follows:

- 1) Sri BibekanandaBouri, Candidate of BJP Party of 246/Raghunathpur AC
- 2) Kartik Tewary, Election Agent of BJP Party of 246/Raghunathpur AC
- 3) Baneswar Mukherjee, Blockdanga, Raghunathpur
- 4) Falguni Mishra, Dhobapara, Raghunathpur.
- 5) Swapnesh Das, Tantipara, Raghunathpur
- 6) Ujjwal Banerjee of Barikbandh, Raghunathpur and 500 others.

I therefore pray that a cog case may kindly be started against the above noted persons and arrange for its investigation.
