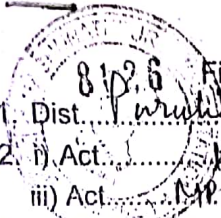

Respected Sir

It is submitted that, I the undersigned Coy. Commando of AE-21 (WB) Coy No-564/517-C and In-charge of QRT Team no-164. on dated 27/03/21 at about 1530 hrs sector officer informed me that some people assembled at Kalajara, near Polling Station no- 245787 and 245788 Kalajara Prathamie Bidyalaya, where our Coy's one section of 08 persons with one sub-officer have deployed and area of under QRT Team no-164. Accordingly I with QRT Team one sub-officer, 07 other rank and one Police ASI Chandan Pal rushed to the spot, at that time sector officer Shri Sukanta Ghosh Insp/Bew SPD was already present on the spot, on his direction we all proceeded towards crowd assembled on narrow road, in the mean time about 1605 hrs started stone peltting on CAPR vehicles discriminantly from opposite side of the road with out any provocation. As result windshited has broken of one of QRT vehicle bearing Reg no- WB-38T-2718.

Above said Public/miscreants try to create obstruction of govt work and damage Govt vehicles.

In view of the above it is requested that may take suitable action against them and take necessary ~~and~~ legal action at your end please.
