Sir,
In producing herewith arrested accused Nripen Mondal (42), S/O Lt. Asutosh Mondal of Vill. – Aguibari PS – Raghunathpur, Dist. – Purulia A/P BCW Bus-stand, PS-Santaldih, Dist-Purulia along with seizure – list and seized items as described below, I beg to state that on 04.03.2021 at about 18:05 hrs I, SI Dipankar Biswas of Santaldih I.C. (BCW) under Santaldih PS received a source information to the effect that the country liquor have been kept and selling at BCW Bus-stand of above noted accused illegally with an object to sale. I convey the matter to duty officer ASI Sukhendu Mondal over telephone. He has diarized the information under Santaldih P.S. GDE No- 178, dated- 04.03.2021 and as per order of I.C Santaldih PS, I along with force left for BCW Bus-stand to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the BCW Bus-stand in the house of above said accused at about 18:20 hours. Seeing police, some unknown persons fled

However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the house. However, I along with said accd. started a search inside the house and found the following item in the said house.

- (1) 13 (Thirteen) bottles 80UP country spirit (Dil Khus) each bottles containing 600 ML market value of each being in total approx Rs. 455/ (Four hundred fifty five only),
- 01 (one) bottle of 600 ML taken out of the above as sample packet, labeled and sealed with sealing wax.
- (2) Cash Rs. 120/- (One hundred twenty) as sale proceed.

away in front of the house of the above noted person at BCW Bus-stand.

I, interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 18:45 hrs to 19:05 hrs & took up one bottle as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the C.S illegally without any valid papers for the purpose of selling in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 19:15 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the accused Nripen Mondal (42), S/O Lt. Asutosh Mondal of Vill. – Aguibari PS – Raghunathpur, Dist. – Purulia **A/P** BCW Bus-stand, PS-Santaldih, Dist- Purulia.
