**Sub : Prayer for lodging FIR against accused Bholanath Mondal (48), S/O Lt. Basudeb Mondal of Kharbari, PS - Raghunathpur, Dist. - Purulia presently at BCW Bus-stand, PS- Santaldih, Dist. - Purulia U/S 46A (c) B.E. Act 1909.**

Sir,

In producing herewith arrested accused person Bholanath Mondal (48), S/O Lt. Basudeb Mondal of Kharbari, PS - Raghunathpur, Dist. - Purulia presently at BCW Bus-stand, PS- Santaldih, Dist. - Purulia along with seizure list and seized items as described below. I beg to state that on 12/03/2021 at 20.45 hrs, I SI Dipankar Biswas, In-charge Santaldih I.C. (BCW) under Santaldih PS received a source information to the effect that the country liquor have been kept and selling at Cinematola More in a goomty beside Santaldih - Paharigora pitch road of the above noted accused illegally with an object to sale. I, convey the matter to I.C. Santaldih PS and I diarized the information vide Santaldih I.C. BCW GDE no. 163, dt. 12/03/2021 and as per order of I.C. Santaldih I along with force left for Cinematola more to workout the information with the Govt. supplied kits box, containing white cloth, sealing wax, seal, papers, carbon, candals etc. I had been to Cinematola more in the goomty above said accused at 21:05 hrs. On seeing police some unknown persons fled away in front of the goomty of the above noted accused person at Cinematola more.

However, I could detain one among them and asked about his identity. He disclosed his name and identity as and as well informed also that he has stocked the country spirit for selling and he was the owner of the goomty. However, I along with said accused started a search inside the goomty and found the following items in the said goomty.

- 1) 12 twelve bottles 80UP country spirit - **Dilkhus**- each bottle containing 600 ML which market value @ Rs. 50/- each, being in total Rs. - 600/- (six hundred only),  
**01 (one)** bottle of 600 ML taken out of the above as sample packet labeled and sealed with sealing wax.
- 2) Cash Rs. 130/- (one hundred thrity) as sale proceed.

I, interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However, he could not show any documents / papers in support of the possession as well as sale of the said articles .

As such I seized the above items as alamat under proper seizure list between 21:15 to 21:25 hrs and took up one bottle as sample, labeled and sealed accordingly.

Since the allegation of him of possessing, the C.S illegally without any valid papers for the purpose of selling in this goomty has prima facie been made out and for the interest of proper investigation. I arrested the above accused at 21.30 hrs accordingly.

Therefore, I, pray before you to start a specific case under proper section of law against the accused Bholanath Mondal (48), S/O Lt. Basudeb Mondal of Kharbari, PS - Raghunathpur, Dist. - Purulia presently at BCW Bus-stand, PS- Santaldih, Dist. - Purulia.
