Sub: Prayer for lodging FIR against accused Kashinath Mondal (55), S/O Sri Radhanath Mondal of Alladih, PS- Santaldih, Dist. – Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused person Kashinath Mondal (55), S/O Sri Radhanath Mondal of Alladih, PS- Santaldih, Dist. – Purulia along with seizure list and seized items as described below. I beg to state that on 13/03/2021 at 16.55 hrs, I, ASI Subhas Ch. Mahato of Santaldih PS received a source information to the effect that the country liquor have been kept and selling at Alladih village in the house of the above noted accused illegally with an object to sale. I, convey the matter to I.C. Santaldih PS and diarized the information vide Santaldih PS GDE no. 583, dt. 13/03/2021 and as per order of I.C. Santaldih I along with force left for alladih village to workout the information with the Govt. supplied kits box, containing white cloth, sealing wax, seal, papers, carbon, candles etc. I had been to Alladih village in the house of above noted accused at 17:25 hrs. On seeing police some unknown persons fled away in front of the house of the above noted accused person at Alladih village.

However, I could detain one among them and asked about his identity. He disclosed his name and identity as noted above and he also informed that, he has stocked the country spirit for selling and he was the owner of the house. However, I along with said accused started a search inside the house and found the following items in the said house.

- 1) 11 (eleven) bottles 80UP country spirit DILKHUS- each bottle containing 600 ML which market value @ Rs. 50/- each, being in total Rs. 550/- (Five hundred fifty only),
 01 (one) bottle of 600 ML taken out of the above as sample packet labeled and sealed with sealing wax.
- 2) Cash Rs. 105/- (one hundred five only) as sale proceed.

I, interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However, he could not show any documents / papers in support of the possession as well as sale of the said articles.

As such I seized the above items as alamat under proper seizure list between 17:35 to 17:50 hrs and took up one bottle as sample, labeled and sealed accordingly.

Since the allegation of him of possessing, the C.S illegally without any valid papers for the purpose of selling in his house has prima facie been made out and for the interest of proper investigation. I arrested the above accused at 18:05 hrs accordingly.

Therefore, I, pray before you to start a specific case under proper section of law against the accused Kashinath Mondal (55), S/O Sri Radhanath Mondal of Alladih, PS- Santaldih, Dist. – Purulia.
