In producing herewith an arrested accused person namely Sarju Aghori (25), S/O Lt. Chaitu Aghori of kanki-Srirampur, PS - Santaldih, A/P Vill. - Bhelatard, PS - Santaldih, Dist. -Purulia with seized articles as an improvised country made fire arms loaded with 1 round live ammunition in proper seizure list duly signed by the witnesses, I, SI Dipankar Biswas of Santaldih I.C (BCW) do hereby lodge complaint that today (14/03/2021) at 00:05 hrs when myself along with C/137 Raju Mukherjee and C/1262 Haru Pandit all of Santaldih I.C. (BCW) under this PS were engaged in night patrolling duty at Cinematola more and on that time received a secret source information that a person is moving suspiciously on Santaldih - Chelyama road at Ushir college more near Santaldih College under Santaldih PS. I, informed the matter to I.C. Santaldih PS and duty officer. He diarized the matter in G.D. vide Santaldih P.S. G.D.E. no. 698, dated 14/03/2021 and as per order of I.C. Santaldih PS myself along with force left for Ushir college more to workout the information. Myself along with force reached on Chelyama - Santaldih road near Ushir college more at 00:15 hrs and found a person was moving suspiciously on that place after seeing the police vehicle he tried to fled away. After a hot chase, we could able to intercept him. Being asked he disclosed his identity as above but he gave in-coherent statements for his presence there. Then, I searched him and found an improvised country made fire arms loaded with one round live ammunition from his exclusive possession. I asked him to produce valid license in respect of said fire arms but he failed to produce any valid documents in respect of possessing of said fire arms and ammunition. So, I seized said improvised country made fire arms loaded with one round live ammunition in between 00:20 and 00:35 hrs after preparing proper seizure list duly signed by the witnesses. I also arrested the above noted accused person in 00:40 hrs after maintaining all the formalities regarding arrest as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. I also tried to collect the public witnesses but the place was lonely and nobody was available there to sign on the seizure list as public witness. After returned to P.S, myself produced the arrested accused along with seized fire arms and live ammunition to start a specific case as per law.

Under above circumstances, I, therefore, pray that a case U/S 25(1)(a)/27 of Arms Act may kindly be initiated against accused Sarju Aghori (25), S/O Lt. Chaitu Aghori of kanki-Srirampur, PS – Santaldih, A/P Vill. – Bhelatard, PS – Santaldih, Dist. –Purulia.
