Respected Sir,

In producing here with the arrested accused person namely Subhajit Besra @ Naren (28 Yrs), S/O- Pralhad Besra of Vill- Jagannathdih, P.S - Santuri, Dist - Purulia along with 13 (Thirteen) liters 800 ml Country Spirit (23 bottle X 600ml) value of Rs- 40 approx X 23= 920/- seized under proper seizure list, I beg to submit that today (on 05.03.2021) I along with force while performing mobile duty at about 17:15 hrs received a credible source information that one person namely Subhajit Besra @ Naren (28 Yrs), S/O- Pralhad Besra of Vill- Jagannathdih, P.S - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license on open place near Jadurdih football ground, P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot to work out the source information and held raid of above mentioned place and found some persons seeing the Police personnel, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Country Spirit bottles for sale. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him. Then, I seized and labeled 23 (twenty three) bottle 'DIL SE' country spirit containing 600ml each bottle and amounting Rs-40/- (Forty) each bottle, Total amounting Rs.920/- under proper seizure list duly signed by the witnesses. From the seized bottles one bottle is sealed and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Subhajit Besra @.Naren (28 Yrs), S/O- Pralhad Besra of Vill- Jagannathdih, P.S - Santuri, Dist - Purulia and arrange for its investigation.
