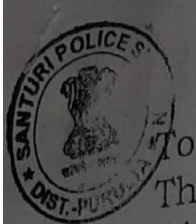

Sir,

In producing herewith the accused Md Raja Ray (27), S/O- Lt Md. Kalu of Vill - Kankdiha, P.S- Para, Dist- Purulia, before you and with one improvised country made fire arms having 23 Cm length (9 inch) wooden Butt, firing pin, and triggered as working condition with one live cartridge sealed and labeled which were seized from his exclusive possession. I, ASI Gurucharan Sahis of Santuri PS am to state that Today (07.03.21) during my night mobile duty along with C/ 330 Banamali Soren and C/ 1485 Swarup Nandi of Santuri P.S vide GDE No. 274 dtd 06.03.21 and CC No. 844/21 when we reached (at 02:15 Hrs) at Rambhattadi morh under Santuri P.S then found one suspicious person run from that place. On seeing this incident we also chased him and can able to nab him. After that I searched him and found one Improvised country made fire arms loaded with one live cartridge from the back waist inside the pant of that person. I safely took out the gun from his waist and unloaded the gun safely after keeping all safety measures. On asked he discloses his identity as Md. Raja Ray (27), S/O- Lt Md. Kalu of Vill - Kankdiha, P.S- Para, Dist- Purulia and he failed to give any satisfactory account in support of possession of that improvised country made gun loaded with live cartridge with him and could not produce any valid document/Paper in support of it. Moreover on asked, he made different statement in different time. So I arrested him informing him the ground of arrest and seized the one improvised country made fire arms having length of 23 Cms (09 innch) with Wooden Butt, firing pin and trigger is working condition and one live cartridge (8 MM, K.F) on the spot in presence Police party preparing proper seizure list, duly signed by them and labeled the same in presence of witnesses. During this odd hour we could not found any public witness. After that I took Md Raja Ray (27), S/O- Lt Md Kalu of Vill - Kankdiha, P.S- Para, Dist- Purulia, in custody and the seized fire arms and ammunition as alat and bought him in PS and produced before you.

Under the above circumstances, I am pray before you to start a specific case under proper section of law against Md Raja Ray (27), S/O- Lt Md Kalu of Vill - Kankdiha, P.S- Para, Dist- Purulia and obliged.
