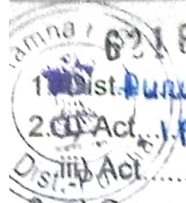

Respected Sir,

In producing herewith the driver namely Raban Bauri (32 yrs) S/O Satis Bauri of Vill- Damda, P.O- Simulia, PS- Tamna, Dist- Purulia along with seized Tractor bearing Reg. No- WB55A/8843 attached with Trolley loaded with sand (Approx 100 cft.) and Seizure list, Memo of Arrest in respect of the supra person before you.


The nub of the fact in a nutshell is that on 04.03.2021 at 16:55 hrs while I ASI Sudip Mukherjee along with force 1) JC/1461 Sajid Ansary, 2) NVF- 774 Nityananda Kuiry all of Tamna PS left the PS for performing evening & night mobile duty vide Tamna PS CC No- 522/21 and GDE No 190 Dt. 04.03.2021 in PS area. During my mobile duty, I received a tip off at 02:15 hrs that 01 (one) suspicious tractor loaded with sand was coming from River bed of Kansai, Simulia. Subsequently, I along with force proceeded towards of Kansai River bed to work out the tip off. While I along with force arrived at Kansai River bed, in-between Railway bridge and Kansai bridge, found that 01 (one) tractor was proceeding towards Simulia. I along with force intercepted the said Tractor bearing Reg. No- WB55A/8843 attached with Trolley loaded with sand (Approx- 100 cft.) at 02:45 hrs and I found that the Tractor as well as goods as identical as I received prior information. On being asked, the driver of the Tractor disclosed his name as noted above. I asked the driver of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded sand (Approx- 100 cft.). But the driver of the said Tractor could not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the drivers of the tractor loaded the said sand in cahoots with the owner of Tractor by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasoned to belief that the accd. in cahoots with the owner of Tractor procured the said sand form Kansai River in between Railway bridge and Kansai bridge by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the Tractor bearing Reg. No- WB55A/8843 attached with Trolley loaded with sand (Approx- 100 cft.) under proper Seizure List in presence of available witnesses duly signed by them and also arrested the driver namely Ratan Bauri (32 yrs) S/O Satis Bauri of Vill- Damda, P.O- Simulia, PS- Tamna, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Tamna PS compound.

Under the above facts and circumstances, kindly take lawful action against the driver of the tractor bearing No- WB55A/8843 namely Ratan Bauri (32 yrs) S/O Satis Bauri of Vill- Damda, P.O- Simulia, PS- Tamna, Dist- Purulia and the owner of the Tractor as they committed offence u/s 379/411/414/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957
