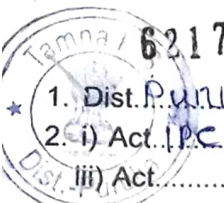

Sir,

I, ASI Gopal Ch. Hembram, (53 yrs) S/O- Lt. Ramchandra Hembram along with force return to PS and brought under seizure 01(One) seized Tractor bearing Registration No- WB55B/3872 attached with sand loaded trolley and lodged this complaint to the effect that on 06/03/2021, myself along with force C/2694 Subarna Singha Mahapatra and JC/1461 Sajid Ansary were performing PS area special mobile duty. During my mobile duty at about 19:05 hrs received credible source information that an owner of tractor was extracting sand illegally at Kansai river bed near Baligara Pump House. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor at Kansai river bed near Baligara Pump House under Tamna PS at about 19:25 hrs and found the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft). But seeing the Police Party, driver of Tractor fled away leaving his Tractor with sand loaded trolley at Kansai river bed near Baligara Pump House. We tried to apprehend him but failed. So there is every ground to reason to believe that the owner and driver of above noted Tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained Tractor. So, I seized the above noted Tractor having its Registration No- WB55B/3872 with attached sand loaded Trolley (approx 100 cft).

On return to Tamna P.S., kept the aforesaid sand loaded seized tractor at PS compound and I do here by submitting written complaint before you to start a cog case against the Owner and Driver of the Tractor having its Registration No- WB55B/3872 under proper section of law.
