Respected Sir,

In producing herewith arrested accd. person namely Dulal Modak (35) s/o Nimai Modak of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia and seized (i) 02 (Two) Bottles Bacardi Rum (275 ml.) @ Rs- 90/- each, (ii) 20 (twenty) Bottles Officers Choice Whisky (180 ml.) @ Rs- 140/- each, (iii) 02 (Two) bottles Tuborg Beer (330 ml.) @ Rs- 61/- each, (iv) 02 (Two) bottles Kingfisher Beer (650 ml.) @ Rs- 130/- each, (v) 07 (Seven) bottles Magic Moment Vod ka (180 ml.) @ Rs- 185/- each, vi) 23 (Twenty three) bottles McDowells XXX Rum (180 ml.) @ Rs- 153/- each and vii) 02 (Two) bottles McDowells (750 ml.) @ Rs- 450/- each all as sealed conditions under proper Seizure List duly signed by the above noted arrested accused person and witnesses.

I beg to submit that on today 21.03.2021 in course of my special mobile duty I received credible source information that the above noted arrested accused person is keeping and selling liquor at his variety store situated at Chakaltore Village. Accordingly myself along with force reached at the said "Dulal Variety Store" at about 18:35 hrs and found that one person is keeping & selling liquor from his "Dulal Variety Store" situated at Chakaltore village under Tamna P.S and seeing the police party two/three persons were fled away from his Variety store and then there held raid and managed to apprehend one. On being asked, he disclosed his identity as noted above and also stated that he is the owner of "Dulal Variety Store" and he himself selling and keeping the said Liquor and confessed his guilty. On demand he failed to produce any valid documents in respect of stock and selling of liquors at his "Dulal Variety Store" and could not give any satisfactory answer for selling and keeping of liquor. So, I seized the above noted articles under proper seizure list duly signed by the witness & accused person and labeled by me. I arrested him after informing the ground of arrest and also issued Memo of Arrest. After arrival at Tamna P.S, I put the above noted arrested accd. person in P.S lock up after maintaining all formalities as per law.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against the arrested accd. person namely Dulal Modak (35) s/o Nimai Modak of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia. under proper section as per law.
