Respected Sir,

In producing herewith arrested accd. person namely Ranjit Kumar Rajwar (28 yrs) s/o Lt. Apish Rajwar of Vill- Gobindapur, P.S- Tamna, Dist.- Purulia and seized (i) 14 (fourteen) Bottles DIL KHUSH (600 ml.) as sealed condition, (ii) 03 (three ) Bottles DIL KHUSH (300 ml.) as sealed condition, (iii) 01 (one) bottle MacDowell (375 ml.) as sealed condition, (iv) 07 (seven) bottles MacDowell (180 ml.) as sealed condition, (v) 08 (eight) bottles Officer Choice (180 ml.) as sealed condition and vi) ½ bottle Officer Choice Blue (180 ml.) in open condition under proper Seizure List duly signed by the above noted arrested accused person and witnesses.

I beg to submit that on today 04.03.2021 in course of my special mobile duty myself along with force reached at Gobindapur more at about 18:45 hrs and found one person keeping & selling liquor from his Pan stall situated at Gobindapur more under Tamna P.S and seeing the police party two/three persons fled away from his Pan stall and then there held raid and managed to apprehend one. On being asked his identity he disclosed his identity as noted above and also stated that he is the owner of the Pan stall and he himself selling and keeping the said Liquor and confessed his guilty. On demand he failed to produce any valid documents in respect of stock and selling of liquors at his Pan stall and could not give any satisfactory answer for selling and keeping of liquor. So, I seized the above noted articles under proper seizure list duly signed by the witness & accused person and labeled by me. I arrested him after informing the ground of arrest and also issued Memo of Arrest as per Cr.P.C. After arrival at Tamna P.S I put the above noted arrested accd. person in P.S lock up after maintaining all formalities as per law.

I then thoroughly and carefully enquired in to the matter and from enquiry it reveals that the above noted accd. person as well as the owner of the said Pan stall running the clandestine business since long which comes under the purview of section 46 of B.E. Act.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against the arrested accd. person namely Ranjit Kumar Rajwar (28 yrs) s/o Lt. Apish Rajwar of Vill- Gobindapur, P.S.- Tamna, Dist.- Purulia.
