of India, 65 yrs. old, my name is Bishnupada Chakrabarti
S/o Late Bhabatach Chakrabarty reside at Subhas Nagar Adra

On 26.3.2021 at about 01 P.M I went to Ramchandra Variety
Store Kashiwore more, Adra. At that time one Kolyan Choud-
hary S/o Late Sailem Choudhary came to me and started argu-
ment for a matter of installing cable line Board at back
side wall of my house. Suddenly he attacked me throwing
feast & blow & also used filthy languages to me. As a
result I received grievous bleeding injury & about to
senseless there. I am a cardiac patient so this type of
attack may cause of my death. Some local people rescued
me from there and there after I shifted to Adra S.E. Rly.
Hospital for treatment. Next day I went to Rupnarayan
family & there I treated at Chittaranjan Rly. Hospital & also
treated at Asansol Rly. Hospital.

Hence I request your honour to take necessary legal
action against the above noted person & oblige.
