Sir,

In producing here with the arrested accd. person namely Lokesh Mondal, S/O Ajit Kumar Mondal Vill- Dumurhir, PS-Neturia, Dist-Purulia. Driver of the Track(709)No WB 55 3837 and seized the track No WB 55 3837 loaded with approx 10 Tons coal .Fact of the case in brief is that on 04.04.21 myself along with officer & forces, ASI Falguni Sarkar C/1434 Jaganath Mondal and C/677 Syed Julhar Ali all of Adra PS were performing special mobile duty in Adra PS area vide CC No-1131/21 dtd.-04.04.21 ,at about 02.15 hrs on 05.04.21 received a credible source information that the above noted track loaded with coal was coming from Raghunathpur side towards Adra side through Raghunathpur-Adra pitch road. Receiving such information I informed the matter to I/C Adra PS and as per his kind direction we reached near Lower Beniasol and waiting there, at about 03.05 hrs we noticed that one Track was coming from Raghunathpur side , we stopped the said track and on searching it is found the registration on the Track and is WB 55 3837 and approx 10 tons coal was loaded in track. On asking driver of the said Track made in coherent statement in respect of possession of the said coal which he was driving. So it is reasonable to believe that the driver and owner of the said Track collected the said coal either by theft or by any fraudulent means from anywhere and Transporting the same to the clandestine business for wrongful gains with the help of others associates. On Interrogation the driver of the said Track confessed his guilt, also stated that the said coal was heaved from a illegal Mine by his associates. As such it is every reason to believe that the driver and owner of the said track no WB-55-3837 and others are transporting the coal illegally. As such I arrested the accused driver of the above noted Track namely Lokesh Mondal(33)S/O Ajit Kumar Mondal Vill-Dumurhir PS-Neturia, Dist-Purulia after observing all formalities and narrating him the ground of arrest I also seized the Track having registration No WB-55-3837 loaded with approx 10 Tons coal under proper seizure list duly sing by the driver and witness , no public witness was available there. Approx 01(one) Kg of coal sealed labeled as sample coal from major contraband.

I therefore pray before you kindly lodge as FIR against the arrested Track driver Namely Lokesh Mondal(33)S/O Ajit Kumar Mondal Vill-Dumurhir PS-Neturia, Dist-Purulia and also owner of the Track and other associated as per law and arrange for its investigation.
