Sub: To lodge FIR against owners and drivers of (i) Mahindra B275 DI tractor having Regd. number WB55A- 7927 along with trolley (ii) Power Truck EURO 439 having Regd. number WB55B-4219 along with trolley (iii) NEW HOLLAND 3037 having Regd. number WB55A-8852 along with trolley (iv) Mahindra 415 DI having Regd. number WB55B-1981 along with trolley (v) NEW HOLLAND 3037 having Regd. number WB55B-2176 along with trolley, each trolley loaded with sand.

Sir,

In producing herewith, 05(five) (i) Mahindra B275 DI tractor having Regd. number WB55A-7927 engine no. RJB2EAN2323 and chassis no. MBNABEXPJRB05042 along with trolley (Red yellow) (ii) Power Truck EURO 439 having Regd. number WB55B-4219 engine no. E3582131 and chassis no. T053517628HJ along with trolley (Blue) (iii) NEW HOLLAND- 3037 having Regd. number WB55A-8852 engine no. S325J72492 and chassis no. NHN30370ZJJ442239 along with trolley (blue) (iv) Mahindra 415 DI having Regd. number WB55B-1981, engine no. RJJ4YBA5263 and chassis no. MBNAAAVAPKRK03283 along with trolley (blue) having Regd. no. WB55B-2034 (v) NEW HOLLAND 3037 having Regd. number WB55B-2176 engine no. S325K39589, and chassis no. NHN30370ZK0479263 along with trolley (blue). Today on 03.04.2021 at about 11:45 hrs. acting on source information, I SI Supratik Mondal of Arsha PS along with (i) C/-583 Khirod Baran Sardar of Arsha PS (ii) C/- 264 Bijan Biswas and (iii) C/- 963 Sourav Santra both of SAP 7<sup>th</sup> BN Camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 67/21 Dtd. 03.04.21. After we reached at Beldih village under Arsha PS at 12:45 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 05(five) Tractor along with 05 trolley attached with by a hinge was present at Beldih Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Kansai River, fled away. Police rushed to the Tractor and detained the said tractors. Police searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, seized the above noted tractors along with trolleys loaded with sand and brought the said tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors vide along with the trolleys and unknown others for investigation.
