Sub: To lodge FIR against owner and driver of Mahindra B275 DI (Red) tractor vide Regd. number WB55B-3284 along with trolley loaded with sand.

Sir,

'In producing herewith, 01(one) Mahindra B 275 DI Tractor (red colour) having Reg. No-WB55B- 3284, engine number RLC2EMN0058 and Chassis number MBNABAEXKLJC02353 along with 01 (one) trolley. Today on 17.04.2021 at about 07:25 hrs. acting on source information, I ASI Susanta Mishra of Arsha PS along with (i) C/-694 Nikibuddin Khan of Arsha PS (ii) C/- 499 Milan Bera of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 511 Dtd. 17.04.21. After we reached at Jaratanr village under Arsha PS at 18:05 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01(one) Tractor along with 01 trolley attached with by a hinge was present at Jaratanr Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kansai River, fled away. Police rushed to the Tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley and brought the said tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of tractor vide number WB55B-3284 along with the trolley and unknown others for investigation.
