In producing herewith, 10(ten) (i) Power truck 434 Plus without Reg. number, engine no. E3594430 and chassis no. TO53528873KK along with trolley (ii) Power truck 434 DS having Regd. number WB55A-5840 engine no. E3369132 and chassis no. T053329604LF along with trolley (iii) Shaktiman-30 without Reg. number, engine no. S30KF4796 and chassis no. C05556238R3 along with trolley (iv) NEW HOLLAND 3032 having Regd. number JH09Z-7523, engine no. N/A and chassis no. NH4296687 along with trolley (v) Mahindra B275 DI without Regd. number, engine no. RLF2EAN2192, and chassis no. MBNABAEXKLR0336 along with trolley (vi) Mahindra B275 DI without Regd. number, engine no. RFNE03943, and chassis no. Today on 22.04.2021 at about 15:20 hrs. acting on source information, I ASI Susanta Mishra of Arsha PS along with (i) C/-226 Debtosh Mudi (ii) C/- 264 Bijan Biswas both of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for mobile duty at PS area vide C.C No. 928/21 Dtd. 22.04.2021. After we reached at Bamundiha village under Arsha PS at 16:15 hrs, we conducted raid on the Bank of River Kansai near Bamundiha Ghat under Arsha PS and found that 10 (ten) Tractor along with 10 trolley attached with by a hinge were present at Bamundiha Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys at Kansai River, fled away. Police rushed to the tractors and detained the said tractors. Police searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending tractors. Hence, I seized the above noted tractors along with trolleys loaded with sand (approx 60 CFT of each trolley) and brought the said tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors vide along with the trolleys and unknown others for investigation.
