Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 16:15 hrs to 17:15 hrs and brought to PS.
