
I am producing herewith following arrested accused persons for the fact that, today (29.04.2021) during my mobile duty (Arsha PS GDE No. 896 dtd 29.04.2021) with (i) C/17 Tapas Kr. Meta (ii) C/316 Nirmal Biswas both of SAP 7th BN Camp at Arsha PS vide Arsha PS CC No. 971/21 dtd 29.01.2021 had been at Arsha Nayarore and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all the violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.05 hrs to 18.05 hrs and brought to PS.
