

Sub: Complaint for lodging FIR against Shikar Chandra Murmu (28 Years) S/O Late- Ghasiram Murmu of Vill- Usuldungri, PS- Baghmundi, Dist- Purulia under E.S. Act.

Sir,

In producing herewith the following arrested accused person namely Shikar Chandra Murmu (28 Years) S/O Late- Ghasiram Murmu of Vill- Usuldungri, PS- Baghmundi, Dist-Purulia in custody, along with following articles:-

I beg to inform that on 08/04/2021 night on receipt of a credible information from accused Shikar Chandra Murmu (28 Years) S/O Late- Ghasiram Murmu of Vill- Usuldungri, PS- Baghmundi, Dist- Purulia during PC period Baghmundi PS Case No-19/2021, Dtd: 07.04.2021, U/S-399/402 IPC & 25/27 Arms Act that some explosive materials have been kept concealed by this professional criminal when dealing with other crimes in clandestinely operating manner. A good quantity of such articles and he manufactured himself for use in to different crimes for wrongful gain. Information revealed that the said criminal used to carry his stock of such articles for commission of offences against human body or properties. He also stated that he will co-operate police for recovery of the explosives. Accordingly I informed my superior officers and obtained permission. Diarized the disclosure of the fact vide Baghmundi PS GD entry No- 261, Date-08.04.2021. As per their kind consent a team of myself and comprising of ASI (AB) Joydeb Patra, C/94 Ratan Kr. Bhoumik, C/785 Akshay Kumar Manna, C/100 Achinta Singha, C/400 Joges Mandi, C/613 Buddheswar Sing, C/435 Kinkar Chandra Nath all of SAP 11th Bn. Camp at Baghmundi PS along with the accused person Sikar Chandra Murmu working out the information. Our vehicle was Tata Sumo car No WB 55A/5600. Then we reached at Edelbera Jungle side area beside from the road. We discovered one white polythin bag containing two bomb like substance under a tree. Then we informed the matter to superiors. As per order of O/C Baghmundi P.S. we cordoning the place where the bombs inside the bag is lying. I also informed BDDS team of CID WB for detection and safe disposal of the explosives. Accordingly around 11.30 Hrs the BDDS Team from CID Purulia unit reached with their equipments at Edelbera. After observing the area and examined thoroughly surrounding areas and took all precautionary measures. We encircled the place to avoid the entry of local peoples for safety reasons. I then disclosed my identity to the present persons in presence of detained persons showing my identity card and the purpose of my raid and also asked their names and address who disclosed their identity as noted (i)SI Subhendu Basani, (ii) ASI (AB) 734- Samir Mandal, (iii) ASI Mahendra Dutta, (iv) WCT/269 Amit Paul all of Purulia BDDS unit. S.D.P.O. Jhalda, CI Balarampur, O/C Baghmundi P.S. reached at the P.O.The said bomb loaded bag handed over to BDDS for proper process. Before starting inventory, search and seizure, I looked for independent witnesses ones again. However, there was hard to get any one. Around 12.35 hrs to

13.45 Hrs the process of inventory, search and seizure started. The inventory list is attached herewith. In between 14.05 hrs to 14.45 Hrs in presence of the aforesaid PC accused person and as shown by him and in presence of witnesses, BDDS team the inventory search, seizure, packing, labeling done. I demanded from the accused person to produce valid documents in support of possession of the explosives (as detected) materials and come under the purview of E.S ACT but he failed to do so. Proper seizure list was prepared, with signatures of witnesses and accused person. The seizure list, inventory list, labels were certified by executive. All the packs were duly packed and sealed. All the articles were seized as alamat of the case. Then I came back to Baghmundi PS and typed this letter of complaint in my laptop/desktop and submitted to O.C Baghmundi PS for staring a case along with the accused person, entire Alamat, seizure list, memo of arrest and all relevant papers. In the light of the above fact I am lodging this complaint against a) Shikar Chandra Murmu (28 Years) S/O Late- Ghasiram Murmu of Vill- Usuldungri, PS- Baghmundi, Dist-Explosive Substance Act 1908 as he has Purulia and request you to start a case u/s 3/4 of violated the provisions of explosive rules and dealing with such deadly items.

Superiors of district have been apprised of the seizure, arrest and other proceedings made so far in this regard.
