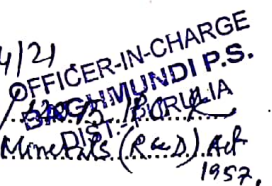
13. Action taken : Since the above report reveals commission of offence(s) u/s 379/411/414/21(1)(4) Mines & Minerals (R&D) Act 1957

Sir,

In producing herewith 02 (two) arrested accused persons namely (1) Mathur Mahato (25 Years) S/O Mangal Mahato (2) Biplab Mahato (25 Years) S/O Ghanenath Mahato both of Vill+PO- Tulin, PS- Jhalda, Dist-Purulia along with seized truck (dumper) bearing No- WB45/0756 with loaded sand under proper seizure list, I beg to submit that today (09/04/2021) I along with (1) C/-610 Achinta Bauri (2) C/1055 Santimoy Samanta of Baghmundi P.S were performing morning Mobile duty vide Baghmundi PS CC No-1152/21 Date-09/04/2021. During my mobile duty at about 13.35 hrs I along with force reached at Matha Duarsini More under Baghmundi PS and found that a truck (Dumper) having Regd. No- WB45/0756 with loaded sand was coming from Jhalda side. On seeing the Police party at Matha Duarsini more, the driver and helper of the said truck (Dumper) were trying to flee away. But after a hot chase, we could able to detain the driver & helper of said truck having No- WB45/0756. I asked the driver Mathur Mahato to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admit that they are dealing with illegal sand lifting from Subarna-Rekha river bed and transporting the sand to Jharkhand area with the help of Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and the owner of the said truck (Dumper) was also involved in this illegal lifting and transportation. Hence, I seized the truck (Dumper) having bearing Regd. No- WB45/0756 loaded with sand in between 14.05 hrs to 14.35 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested (1) Mathur Mahato (25 Years) S/O Mangal Mahato (2) Biplab Mahato (25 Years) S/O Ghanenath Mahato both of Vill+PO- Tulin, PS- Jhalda, Dist-Purulia in between 14.45 hrs to 14.55 hrs. I brought the said sand loaded truck (Dumper) to Baghmundi P.S. compound as such there is every reason to believe that the driver, helper and owner of the vehicle with ill motive are habitually dealing with sand illegally and transport to Jharkhand area without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely (1) Mathur Mahato (25 Years) S/O Mangal Mahato (2) Biplab Mahato (25 Years) S/O Ghanenath Mahato both of Vill+PO- Tulin, PS- Jhalda, Dist-Purulia (3) Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and (4) Owner of truck having bearing Regd. No- WB45/0756 may kindly be started and arrange for its investigation.
