And on perusal of the said Deed the Complainant became very much astonist and as a matter of fact that in the said Deed also accused No. 1 -

3) _____ That, the Complainant begs to submit that, the said Gopeswar Mahato on behalf of his mother-in-law Bhandi Mahatani recovered the consideration money and then he handed over the same to the Vendor Bhandi of ~~es~~ course after continuing the same as he was the guardian of said Bhandi at the relevant point of time and is dead now.

4) _____ That, all the accused persons in consultation and convenience with each other for their personal gain and loss to the Complainant has executed the Deed in favour of Raghynath Mahato.

But fact remain that, the Complainant since the date of purchase is possessing the land. But presently the accused persons are threatening the Complainant and tried to dispossess the Complainant from the land.

That, the Complainant beg to submit that, in such circumstances the accused persons have cheated to be punished under the law.
